

Minutes of 1st Meeting of State Level Monitoring Committee for Monitoring Progress of Shelter for Urban Homeless Constituted by Hon'ble Supreme Court in Writ Petition (Civil) No 55/2003 and associated Writ petition (Civil) No. 572/2003 ER Kumar & Others Vs Union of India & Others held on 11.07.2018 at SUDA Uttar Pradesh, Lucknow.

First Meeting of State Level Monitoring Committee for Monitoring Progress of Shelter of Urban Homeless has been held on 11.07.2018 at 2:00 pm at SUDA, meeting hall under the Chairmanship of Mr. Balvinder Kumar, IAS (Retd.), other members and officials are as follows:

Mission Director briefed the Committee about status of Shelter Home and Urban Homeless in the State, ie there are 173 permanent shelters with the capacity of 6920 persons (121 Non NULM shelters with the capacity of 3766 persons and 52 NULM shelters with the capacity of 3154 persons) that are functional. Apart from these functional shelters, there are 73 NULM shelters under Construction with the capacity of 5027 persons. Thus the total capacity of all shelters is 11947. It has also been informed that State Government also conducted various mobilization activities in all large cities towards sensitization of urban homeless for use of shelter home.

The Mission Director informed the committee that Writ Petition (Civil) No-55/2003 and 572/2003 ER Kumar and Others Vs Union of India and Others for providing shelters urban homeless is ongoing since 2003. Various hearing took place for the same. However the scheme SUH was launched under DAY-NULM only in the month of December 2013.

In this Writ Hon'ble Supreme Court constituted 3 members committee on 11.11.2016 and Govt of India issued the Gazette on 08.12.2016 for the committee to review the scheme under the Chairmanship of Hon'ble Kailash Gambhir, former judge, Hon'ble High Court Delhi along with two members 1) Mr. Neeraj Kumar Retd. Officer of Delhi Higher Judicial Services and 2) Shri Sanjay Kumar, IAS Joint Secretary, Ministry of Housing & Urban Affair, Govt. of India, The Committee visited Lucknow and Kanpur and submitted the report to Hon'ble Supreme Court.

On the basis of report submitted by the Committee, Hon'ble Supreme Court selected 3 States on random basis and passed interim order for U.P to provide Road Map for providing shelter to 1,81,000 urban homeless as per Census 2011. In compliance of the interim order of Hon'ble Supreme Court required Road Map has been submitted to Hon'ble Supreme Court through Affidavit on 08.01.2018. It has also been mentioned in the affidavit that as per State Govt. decision the third party Survey of urban homeless is being conducted by Giri Institute of Development Studies, Lucknow.

The third party survey has been completed and as per Interim report received from Giri Institute of Development Studies, 28407 urban homeless are found in the State of Uttar Pradesh the details are as follows:-

As per third party survey there is gap of 16460 for whom approx 424 shelters need to be constructed. An estimated amount of Rs. 565.75 Cr. (Rs. 441.60Cr for Construction and Rs. 124.15Cr. for O&M) is required. However, In 271 ULB's where no. of Homeless found between a range of 1 to 15 (ie 1813) a temporary arrangement will be made in community centres and unused Govt. buildings.

After an in depth discussion, the following suggestions were made by the committee:

- 1) DAY-NULM Shelters need to be re-looked in terms of safe drinking water, safe sanitation facilities, hand washing unit, recreation, solid and

liquid waste disposal etc, if some infrastructural gap is found then a supplementary DPR need to be prepared and approved.

- 2) Activate District level shelter monitoring committee and take a report on quarterly basis.
- 3) Non DAY- NULM Shelters (Nagar Nigam Shelter) need to be upgraded vertically for providing higher occupancy as per NULM Guidelines.
- 4) Non DAY- NULM Shelters need to be upgraded in-terms of improving the facilities as per NULM guidelines.
- 5) Intensive awareness campaign and mobilisation sessions for urban homeless need to be organized. In this regards services of non-government organisations may be taken. Awareness programme for mobilization and motivation of homeless community is required all round the year with the help of ULB member and local social workers, civil defence, NCC & NSS students and specialized voluntary/community/ Non government organizations.
- 6) Action plan for providing shelter to all homeless found as per 3rd party survey should be prepared.
- 7) Financial demand for construction should be made to GoI.
- 8) Survey of Urban homeless by ULB should be carried out annually and third party survey to be conducted after every three years to know the actual no. of urban homeless.
- 9) Committee members should visit the shelters to know the present status, and progress of shelter homes under construction.
- 10) O&M of all shelters will be given to NGO's.
- 11) Orientation programme for O&M agencies will also be carried out.
- 12) Monitoring of all shelter must be done at regular intervals.
