


I am to refer to the meeting of Committee of Secretaries (CoS) held under the Chairmanship of Cabinet Secretary on 24.7.2018 regarding implementation of the Pradhan Mantri Awas Yojana (Urban) [PMAY(U)] in States/UTs.

2. In this connection and as per the recommendations of the CoS, following actions are required to be taken by the States/UTs urgently:

- a) Convergence of the benefits being provided under other flagship Schemes such as Saubhagya, Ujjwala, AMRUT, Solar Power, Jan Dhan Yojana, PMJJBY, PMSBY etc. with the PMAY(U) may be ensured.
- b) The stock of vacant houses already available in other ongoing & completed housing projects and land banks of different urban development authorities may be used for meeting the target under the PMAY(U).

3. In view of the above, you are, requested to ensure implementation of the above mentioned recommendations of the CoS at the earliest to achieve the target of "Housing for all by 2022". A status report in this regard may also be sent to this Ministry.
