- Is VAT applicable when the supply is to the Government?
 Clarification Yes, VAT is applicable.

For these additional tests it is required to write to the testing agencies and take their consent as these tests are not included in the notifications of Govt. of India, which will take more time and additional fees. Therefore it has been requested that it should be allowed that these tests/certificates may be submitted before delivery so that bid process could be completed in time.
