Purpose Vehicle (CSC SPV)

Sir,

The Ministry of Housing & Urban poverty Alleviation is striving to achieve its goal of 'Housing for All by 2022' through the scheme 'Pradhan Mantri Awas Yojana (Urban)'. The demand assessment by States/ULBs is the first step towards implementation of this mission. In a bid to enable wider outreach, the Government wants to empower the citizen by giving them a facility of enrolling himself/ herself as a 'prospective beneficiary' in PMAY.

2. In order to facilitate the registration of online application form filling for citizens across the Country, a Memorandum of Understanding (MoU) has been signed between CSC e-Governance Services India Limited and Ministry of Housing & Urban Poverty Alleviation (MoHUPA) on 2nd November 2016. The platform of CSC SPV would be utilized by citizens for online form filling. We request all ULBs (Urban Local Bodies) and Implementing Agencies to ask citizens to visit the nearest Common Service Centre for application submission under the Scheme. The application is eKYC enabled and a nominal fee of Rs 25/- + service tax for every application is payable by citizens for the assisted model.

3. All ULBs and Implementing Agencies of all States/ UTs are requested to utilize the Common Service Centre platform in order to accelerate the process of Registration. The data entered by the citizens can be viewed under respective SLNA/ULB logins in PMAY MIS as a part of the demand survey. Any citizen, who has not yet enrolled for Aadhar, can also visit the CSC centre for Aadhar enrolment prior to applying under PMAY Mission.

4. Since the above move is largely in interest of the masses, you may like to propagate and promote this newly introduced facility of filling applications for PMAY (U) through suitable means in your State.
