“Vendor Market Development Proposal (PRJDIP06041700001) received from Gurgaon ULB is approved”.

2.1) SUSV Others Component :

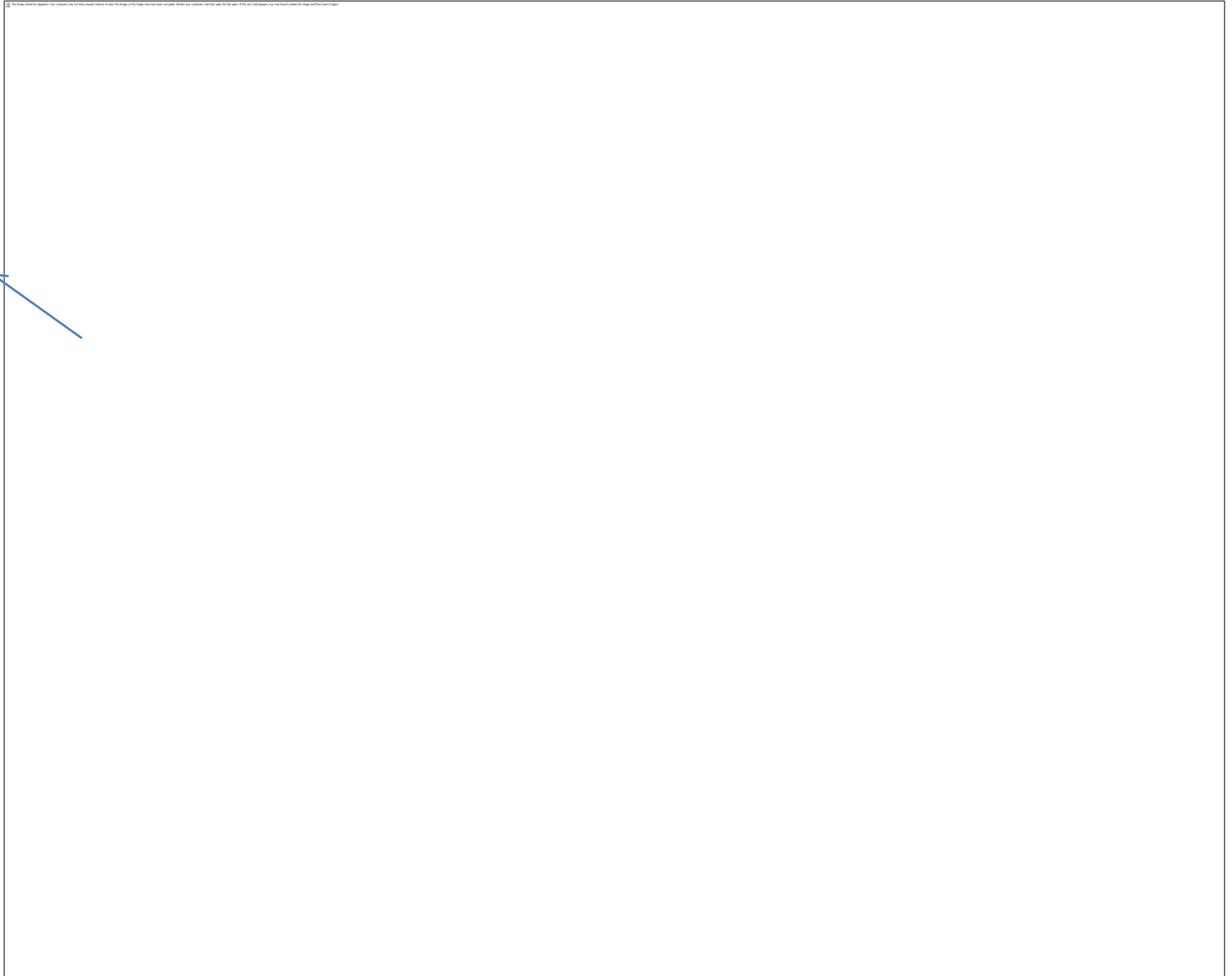
